The CAO has also been in contact with the MNR regarding replacing bailey bridges with culverts. It is possible but must check with the Federal Government regarding the Navigable Waters Act.

Council denied a request from the High School to place a gazebo on town property by the High School.

Council cancelled the park fee for the Live From the Rock festival for 2016.

Council authorized the purchase of equipment at the Snack Bar at the Recreation Centre.

An e-mail from Justus Veldman regarding the mill properties was reviewed.

Payment vouchers for payroll and operations were submitted for approval.
