#### **Chief Administrative Officer**

The CAO reviewed his written report and correspondence sent on behalf of Council.

The replacement of the furnace for the Zamboni Room at the Recreation Centre was awarded to Mahoney Contracting.

Council reviewed the road closures that will result when the new highway is opened. The western end of Red Rock Road #8 will be closed and a turn-around will be installed by the MTO. Red Rock Road #7, the Dump Road and the eastern end of Red Rock Road #8 will be realigned so that they meet the new highway at 90 degrees. Mr. Saunders of the MTO also confirmed that the maintenance on what will be Cantley Drive E & W will continue to be the responsibility of the MTO.
